DURING 2019 WE SUPPORTED FARMER-TO-FARMER AND TECHNICAL EXPERT-LED ASSISTANCE AND EDUCATION INCLUDING FILLING 17 TECHNICAL ASSISTANCE POSITIONS WORKING DIRECTLY WITH LANDOWNERS. IN ADDITION WE PROVIDED FUNDING AND EXPERTISE FOR 13 WEBINARS ON TOPICS INCLUDING AGROFORESTRY, HIGH TUNNEL SOIL MANAGEMENT AND FOOD WASTE REDUCTION. WE ALSO PRODUCED EIGHT VIDEOS ON VARIED TOPICS INCLUDING ON-FARM COMPOSTING, GRAZING AND HIGH TUNNEL SOIL HEALTH PRACTICES AND SUPPORTED 52 ONE-ON-ONE TECHNICAL ASSISTANCE VISITS AND SEVEN PASTURE WALKS FOCUSING ON PRACTICES THAT BENEFIT WATER AND SOIL QUALITY AS WELL AS THE FARM'S BOTTOM LINE.
